### OUR PRIORITIES IN 2010

#### **Reporting results to mainstream schools:**

Nationally we will be examining ways of reporting student results to mainstream schools. This is a complex issue and we are endeavouring to seek funding to do a project which will examine what needs to be done to ensure that results are recognised not only in VCE but from Prep to year 12. This would recognise the efforts of our students and also increase awareness about the work being done in schools.

#### **Elections:**

**This year is an election year.** There will be a State and Federal Election held this year and we will need to lobby Government and the Opposition in seeking additional funding for our programs.

Our aim is to work with our schools to ensure our message to our elected members is a coordinated one. We are planning a GENERAL MEETING on Thursday the 25<sup>th</sup> of February (6pm – 8pm at LMERC) to discuss this important issue.

#### **Social Inclusion and cohesion:**

We need to examine ways of improving communication, social interaction, inclusion, cohesion and harmony. Our work with mainstream schools – host schools has great potential. We should look at how we can engage more closely with them on formal occasions.

E.g. **Education Week in May** is a good opportunity to take our message forward.

## 2009 VICTORIAN LANGUAGES STRATEGY DISCUSSION PAPER

---

The Parliamentary Secretary for Education Steve Herbert MP recently released the Victorian Languages Strategy Discussion Paper in December 2009. The DEECD is now embarking on a consultation process to inform the development of the Languages Strategy in 2010.

Community Languages Australian and the Ethnic Schools association will be presenting to the Panel on Languages Education, chaired by the Parliamentary Secretary for Education, .The presentation will address specific aspects of the Victorian Languages Strategy Discussion Paper 2009. It will also highlight the community languages schools perspective.

## COMMUNITY LANGUAGES SCHOOLS ROUND TABLE

---

A Round Table on Community languages schools was held on November 27, 2009 at the Hume Global Learning Centre in Broadmeadows, chaired by the Parliamentary Secretary for Multicultural affairs, Liz Beattie MP.

### **The issues to be addressed were:**

- Raising awareness of the role of community languages schools as complementary providers;
- Implementation of the Quality Assurance Framework;
- The need to work in partnership between Principals Associations, School Councils, Language Associations and community languages schools;
- Accessing and engaging all major stakeholders;
- National and State/Territory training and PD;
- Increasing retention rates of students studying languages;
- Support for Asian languages programs with a strong commitment to all languages;
- Rental issues.

Active participation of Principal Associations provided some valuable insight into future directions. The next round table is now being planned to engage the Southern and Eastern Regions.

## INSURANCE AND ADMINISTRATION COSTS AND PER CAPITA SUPPORT FOR ESAV AND CLA FROM MEMBERS

---

For the past 10-12 years, members have contributed to the cost of insurance and administration of ESAV through a \$2.00 per capita levy. This is deducted from the grant. This is the best and most

efficient way of collecting the required funds.

There has only been one rise in that time from \$1 to \$2.

The cost of Public Liability is increasing as are many of the administrative costs associated with the ESAV. Our responsibilities have grown, our activities are growing and our Conferences have over 300 participants. We have been fortunate that any extra cost to date have been covered or subsidised from ESAV funds which we receive through various sources.

Nationally, Community Languages Australia (CLA) our national body is also engaging with schools, governments and other stakeholders to ensure that funding from the Commonwealth is there to support schools. The National Council AFESA – CLA has now indicated that each State will need to contribute at least \$1.00 per student to the national work. This is very important as witnessed in the past what happened when we don't coordinate nationally. We are now a united body nationally and have strong outcomes locally, in our case in Victoria.

Being coordinated nationally has given us the following outcomes;

- ✓ Community languages schools written into national policy
- ✓ Community languages schools are seen as complementary providers
- ✓ The National Statement on Community Languages School was developed and accepted
- ✓ The Quality Assurance Framework was developed and training provided
- ✓ National Professional development offered
- ✓ National Conferences introduced
- ✓ National networks formed

Community Languages Australia also has been proactive in negotiating a national insurance policy. This policy is intended to cover schools for other activities as well and will still be cheaper than individual schools seeking out their own public liability insurance.

Given insurance cost have risen, other administrative costs have grown and there are needs to be an additional national contributions, we are requesting that ESAV levy to be increased to \$4.00. In line with this, we are seeking a \$10-\$15 increase in per capita funding from Government. Given it is an election year we will be seeking this increase.

Depending on the outcome, schools will hopefully receive additional funding in 2011 but we have to work hard to achieve this.

All these and other matters we will be discussed at our General meeting on February 25<sup>th</sup>.

## **VRQA REGISTRATION**

---

As you are aware Community Languages Australia is now responsible before the Victorian Registration and Qualifications Authority for all our VCE schools. Last year schools were asked to pay \$350 to cover this registration cost. This step will save schools a huge money as to undertook the process themselves (\$1,600). Our proposal provides a huge saving

The annual payment required to be paid to ESAV to administer the process will be reduced to \$250. Schools offer VCE are requested to pay this by the end of April to the ESAV.

Congratulations to Austurk Language Schools for achieving the state's first two top scores in VCE Turkish in 2009



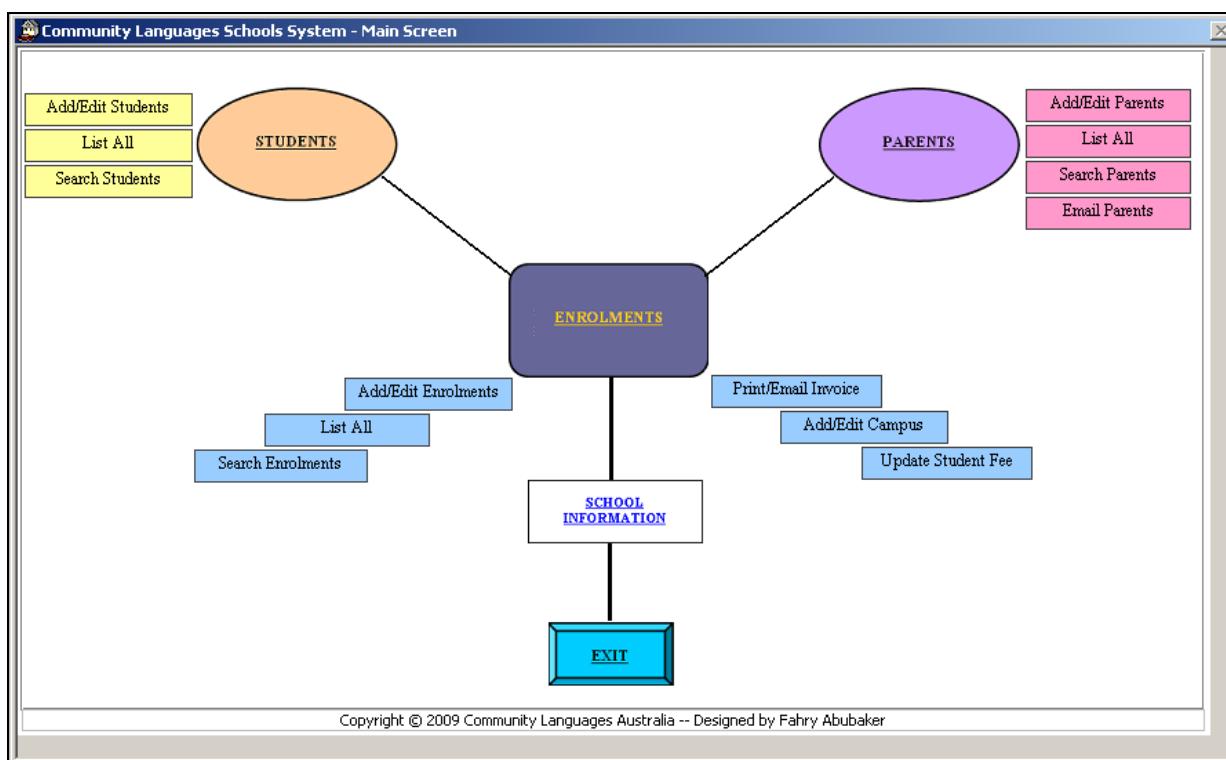
**ADEM CAKSAK- 49, VCE TURKISH TOP SCORER**
